2nd space/Motorhome Storage Fee: \$100.00 per month.
No reserved parking available. Must be parked on west side of lot on either fence line.



TVQMA Parking Policy - Members agree to the following:

All members, in good standing, will be eligible to park and keep their race trailer at the track during the year. This includes being able to keep **race trailers only** at the track on non-race days throughout the year. This is a privilege available to Active Members in Good Standing and storing of race trailers is not to be considered an automatic inclusion in the TVQMA Membership Agreement. Furthermore, the policy is not intended to randomly restrict access or inconvenience members in any way, but to benefit the club in a fundraising capacity for repairs and to keep the club and association fully funded and operational for future families to come. All Club By-Laws, Rules and Track Usage agreement apply.

Specifics include, but not limited to, the terms below:

1. Members must have their membership paid, in full, with both our sanctioning body, POWRi and the club membership with TVMQA. Proof of payment will need to be provided for all 2022 memberships. *By-Laws, Sec.7: MEMBERSHIPS Definition: Dues are paid, and membership is valid when dues, application, **and all appropriate documents are received** (by membership coordinator and/or club treasurer) and approved by local club officer.*
2. Receipt of gate key is contingent on membership signature below AND completion of requirements noted in #1. Previous year's key to be turned in upon receipt of current year key.
3. Only Race Trailers will be allowed to be kept at the track on non-race days. Motorhomes, 5th-Wheels, and box trucks are not considered race trailers and cannot be stored on the property unless approved by the Board and appropriate fees are paid. All others and can be brought in the day before the race and must vacate the property by the end of weekend/day at the completion of the event.
4. Trailers must be used for the storing of quarter midget vehicles only.
5. Member agrees to provide a description of their trailer and license plate with their membership agreement (to be referenced in the event emergency notice of removal needs to be given for any reason).
6. Member(s) agrees to remove their trailer when notified by the Board. In all cases, such as maintenance, repairs, inspections, Board will provide ample notice for removal arrangements.
7. Members racing less than 6 club races during the year agree to park their trailers in the West end of the lot to provide parking access for members for race day events. This includes any and all full-time stored trailers. Parking spot will need to be confirmed with Board President.
8. Tri-Valley Quarter Midget Club will not be responsible for members' trailers, contents, or any damage to member's trailers or property within. Members agree to carry appropriate insurance on their own trailers.
9. Board of Directors will review this policy on an annual basis and to determine fees to be associated with policy.

TRACK USE AGREEMENT- MEMBERSHIP APPLICATION

In order to utilize the track for practice, the following rules must be adhered to. Not following any of these rules will result in the forfeiture of your track key.

Rules

- I agree to follow all the rules stated in the Track Use Agreement.

1. All POWRi safety rules must be adhered to.
2. There must be two adults at the track in case of emergency.
3. Only current POWRi/TVQMA Members may use the facility.
4. The insurance waiver in the pit box MUST be signed.
5. No one is to drive a car without being a POWRi member in good standing.
6. Your assigned key must always remain in your possession and shall not be used by any other person.
7. Flags and fire extinguishers must be used.
8. No one is to be in the pit area unless they are a driver or handler. Handlers are to be no less than 16 years old.
9. When finished for the day, all flags must be returned to pit box.
10. NO motorized scooters, bikes, motorcycles, ATV'S, Autos, dirt or street karts allowed in any are of the race surface, Staging lanes, Hot Chute, or trailer pit area.
11. No warming of engines in covered staging area.
12. Be considerate to those waiting to practice and ensure everyone gets equal time on the track.
13. Repair any wall damage as necessary. Notify the club Vice President if the walls need extensive repair.
14. No tires of any kind shall be left at the track PERIOD!!! You are responsible for disposing of them properly.
15. All trash must be picked up.
16. All pets must be always on a leash. Clean up after your pet.
17. The gate must be locked with the keyed lock upon leaving the facility.

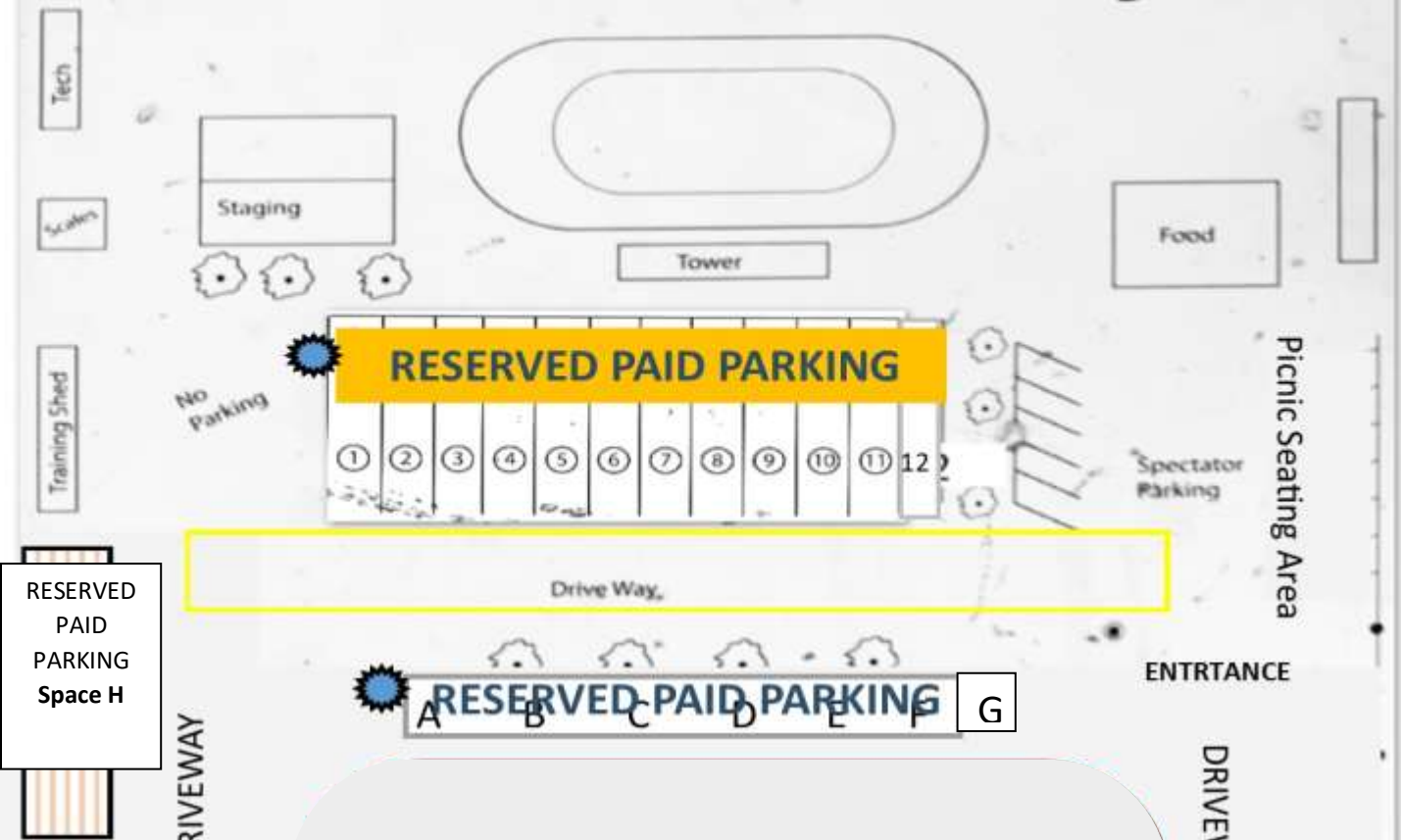
